NEFCO in a nutshell

- international financial institution, established 1990 by the Nordic governments
- NEFCO provides loans and capital investements for environmental projects of interest to the Nordic countries
- we administer funds to a total value of 353 million euros.
- geographic mandate: Russia, Ukraine, Belarus, Estonia, Latvia and Lithuania
- Our current project pipeline lists over 150 projects in Russia
- 62 projects have been implemented and closed so far
- the most common sectors; wastewater treatment, energy efficieency and renewable energy



Experience from investments in renewable energy

- Wind and small hydropower in the Baltics
- Russia
 - several feasibility studies,
 - negotiations on investment in Murmansk windpark (disc.)
- Biogas many proposed few implemented so far





Windpower in Estonia and Lithuania

Vardar Eurus

- Co-investment with Norwegian regional power company
- Holding company with 25-100% ownership
- Installed capacity 72,5 MW
- NEFCO investment 10 mill EUR





Baltic Hydro Energy – small hydro

- Holding company established 2001
- 9 HEPP with total capacity 4100KW and 14,1 GWh average output
- Irrigation dams and water reservoirs
- modernizing and upgrading of turbines and generators

- Industrial investor with competence and solid financial resources
- Quality in procurement contracts and suppliers
